**A. ENGLISH PREPARATORY DEPARTMENT EXEMPTIONS AND EXEMPTION EXAMS**

- To get at least 60/100 points from Haliç University English Preparatory Department Proficiency / Exemption Exam. Newly enrolled students who do not meet the English Preparatory Programme exemption requirements must take this exam. Announcements/information about the exam are also available on the SFL WEB page and in the academic calendar.
- The detection of the English language proficiency status (exam) and the approval of the language proficiency certificates regarding the English Preparatory Programme to be continued by the students admitted to the undergraduate and graduate programmes of Haliç University are carried out by the Directorate of the School of Foreign Languages (SFL).
- Students will also be able to participate in the English Proficiency (Online-Face-to-Face) exam (Q-TEST) to be held between the add/drop dates specified in the academic calendar, provided that they pay the exam fee for each academic semester. For the Haliç University English Preparatory Department Proficiency / Exemption Exam (Other), the passing grade **(Q-TEST English)** must be **at least 60/100** (Students must pay a fee for the Q-TEST English exam.)

***Q TEST (TURKISH-ENGLISH PREPARATORY PROGRAMME EXEMPTION EXAM)***

- *For each academic semester, students will be able to take the English / Turkish Proficiency (online-face-to-face) exam (Q-TEST) to be held between the add / drop dates specified in the academic calendar, provided that they pay the exam fee.*
- *Students who want to be exempt from the Turkish and English Preparatory Programme will be able to take the Q-TEST.*
- *The minimum grade required for exemption from the English/Turkish Preparatory Programme with Q-TEST is 60.*
- *The exam fee is accepted in USD and TL. It will be deposited to the account numbers determined by Haliç University and notified to them. Student number and exam type (Q-TEST) must be written in the explanation section.*
- *Application and payment procedures must be completed until 15.00 at the latest one day before the Q-TEST date. Payments and applications made after this date and time will be accepted for the next exam.*

- ÖSYM exams YDS / YOKDİL score to be at least 60,
- TOEFL IBT score of at least 72 or PTE score of at least 55
- English Preparatory Exemption / Proficiency Exam / HEPPTTEST exam result must be at least 60. (Newly enrolled students will be able to attend for one time only). Unsuccessful students can also take the Q-TEST.
- Students who have enrolled in the programmes of the University whose medium of instruction is English and who have studied in the English Preparatory Department of another higher education institution at the Upper-Intermediate (B2) level within the last two years and who have completed this programme with at least 60 points out of 100 will be exempted from English Preparatory.
- **The English Preparatory exemption condition for application to associate degree/undergraduate programmes whose medium of instruction is English includes the following:** At least in the last three years, in a country where English, which is determined as the medium of instruction, is spoken as the mother tongue, to be educated in secondary education institutions attended by the citizens of that country and to have completed their secondary education in these institutions are the qualifications accepted for exemption.
- **English preparatory exemption requirement for students applying to graduate programmes whose medium of instruction is English;** foreign language proficiency requirement is not required from candidates who graduated from domestic or foreign undergraduate or graduate programmes whose medium of instruction is English.
- Students who have studied English at a university abroad for 2 academic years (1 year) are exempted from **English preparatory and Eng 101- 102 courses.**

## **B. EXEMPTION REQUIREMENTS AND EXEMPTION EXAMS FOR TURKISH PREPARATORY PROGRAMME**

- To have at least 60 points from the **HaliçTR-TYS** (Turkish Preparatory Turkish Exemption / Proficiency) exam conducted by Haliç University SFL (New Enrolment Students will be able to participate for one time only).
- To have a minimum score of 60 in the Q-TEST Turkish Exemption Examination, which is conducted "also" by Haliç University SFL (**Students must pay a fee for the Q-TEST Turkish exam**).
- B2 graduation certificate / B2 certificate (certificate of completion of preparation) obtained from nationally or internationally recognised institutions (Yunus Emre Institute), Turkish Language Teaching Centres (TÖMER) affiliated to Higher Education and Turkish Preparatory units of the School of Foreign Languages and this certificate must be approved by the relevant department of Haliç University SFL.
- **Turkish Preparatory exemption condition for students applying to graduate programmes whose medium of instruction is Turkish;** those who have a bachelor's or master's degree from a higher education institution in Turkey or from an institution accepted as equivalent by the Council of Higher Education are exempt from the Turkish Preparatory Department.

### ***ABOUT ENGLISH / TURKISH EXEMPTION EXAMS!***

- *The validity period of the proficiency certificate obtained from the university preparatory departments is two years. Students who are exempt from the English Preparatory Programme are exempt from ENG 101 and ENG 102 courses in their departments. For ENG 101, students must score 65-69; for ENG 102, students must score 70 and above. Students can take the exempted English courses if they wish.*
- *Students who fail the Turkish or English language proficiency exam among the students placed in Turkish or English programmes are enrolled in the preparatory class for one year. Students who are successful at the end of this period start the first year of the programmes they are enrolled in. Those who fail are given an additional one-year period. Those who fail at the end of this period are dismissed from the University.*
- *International students who are successful in the Turkish Proficiency Exam cannot be exempted from TLI (101-102), TLH (101-102) courses which are compulsory Turkish courses.*

- *The determination of the English/Turkish language proficiency status of the students accepted to the undergraduate and graduate programmes of Haliç University regarding the English/Turkish Preparatory Programme to be continued and the approval of the language proficiency certificates are made by the SFL Directorate.*
